Responding to news of current VA Jaycee membership numbers with gasps, grunts, and "shocked" exasperation is the wrong response from those of us who, as life members, should know better. AND... It's the exact opposite of what our responses should be according to Shawn Achor, Harvard Professor and author of The Happiness Advantage, and Big Potential. In his books, Achor explains through analysis of several multi -year research studies, that the power of a positive mindset can have a ripple effect that increases productivity, and morale, and the overall strength and durability within any organization. A negative mindset can create or strengthen a downward spiral into failure or organizational collapse.

Part of our role as Life Members, as was told to me when I took an oath as Virginia Jaycees State President, is to offer the disputation of negative beliefs/

consequences, to prevent the negative mindset from taking hold. Our role should not be to ridicule, or scoff at the numbers, but to draw attention to and to praise the positive accomplishments of current chapters.

In the very least we should be reaching out to local chapters (unsolicited), to offer encouragement, and let them know that we are paying attention and are proud of/amazed at what they have accomplished, what they are doing, and we stand behind them 100% because what they do is important.

I actually tried a bit of this positive approach out at the Winter Meeting. Whenever I met someone new at the last state meeting, I asked what chapter they were from, and then asked questions about projects I knew that chapter did. Here I was, someone they had never met before, who lived 70 or even 100 miles away mentioning projects they had worked on, sometimes the projects were relatively small. I let them know that the reason I knew about such projects was because their chapter's life members and senators love to brag about them when we gather in our suites at conventions and our Dutch Treat Dinners (OK, so I took a few liberties there, but you get the point). A few of the current members stated they had never met their chapters' life members, and questioned how I could have heard such people brag about current projects. I of

course replied that they may not know us yet, but we know what they are up to because even after all these years, we follow what's going on in our chapters because current chapters are our legacies, etc.

The effect was immediate. Smiles and flashes of energy and enthusiasm appeared on faces. And I ended up spending the banquet listening to current Jaycee chapter members discuss their projects and activities with enthusiasm and charisma (You know, the kind of energy it takes to successfully recruit and retain members?).

Adjournment-The Jaycee Creed was led by Sabitha Venkatesh.


